These Site Terms of Use ("<u>Terms of Use</u>" or "<u>Terms</u>") form an agreement between you ("<u>you</u>" or "<u>your</u>") and American College of Sports Medicine ("<u>ACSM</u>," "<u>we</u>," "<u>us</u>" or "<u>our</u>") and govern your use of acsm.org and any other website owned or operated by ACSM that links to these terms (the "<u>Site</u>") and all features, content, products, and offerings made available on or through the Site (collectively with the Site, the "<u>Services</u>").

READ THESE TERMS CAREFULLY, AS THEY CONTAIN TERMS AND CONDITIONS THAT IMPACT YOUR RIGHTS, OBLIGATIONS, AND REMEDIES IN CONNECTION WITH THE SERVICES, INCLUDING AN AGREEMENT TO ARBITRATE FOR ANY DISPUTE RESOLUTION UNDER SECTION 10 BELOW.

1. ACCEPTANCE

Please read these Terms carefully before you access and use the Services. BY ACCESSING AND USING THE SERVICES YOU ACCEPT AND AGREE TO BE BOUND AND ABIDE BY THESE TERMS. If you do not agree to these Terms, you must (i) not access or use the Services, or (ii) discontinue any access or use of the Services. Your failure to comply with the Terms may result in the suspension or termination of access to the Site and may subject you to civil and criminal penalties.

2. CHANGES TO THE TERMS

ACSM reserves the right, in its sole discretion, to amend the Terms, at any time and without prior notice. All changes are effective immediately when we post them unless we expressly specify otherwise. In any event, no changes will apply retroactively as to any claims existing prior to the "last updated" date. If we choose to amend the Terms, we will update the "Last Updated Date" at the top of the Terms and post the updated version. By continuing to use the Site after we have posted an updated version of the Terms, you are affirming that you agree to be bound by the amended Terms. You are expected to check this page, so you are aware of any changes, as they are binding on you. If there are material changes to these Terms, we may also reserve the right to provide notice of said changes in other alternative manners, such as posting said changes to the Site and/or communicating said changes via e-mail or other communication channel.

3. ACCESS AND CHANGES TO THE WEBSITE

Subject to your compliance with the Terms, ACSM grants you a limited, revocable, non-exclusive, non-transferable, non-assignable, and non-sublicensable right to access and use the Site for your own personal or internal business use only, and not for resale or third-party distribution. In order to use the Site, you must have internet access, otherwise, you will not be able to use some or all of the Site.

ACSM reserves the right, in its sole discretion, to modify or discontinue offering the Site, or to impose limits on your use of the Site, or any features, functionality, or tools thereof, in whole or in part, at any time, for any reason or no reason, with or without notice to you. Our website incorporates the use of third-party technologies, including cookies and other tracking technologies to enhance user experience and to analyze performance and traffic on our Website ("Cookies"). Cookies and related information collected about your use of our Website may be shared with our social media, advertising, and analytics partners. For more information about our use of Cookies and how we may share information with third parties, please see our privacy policy found on our Site.

6. PURCHASES

- 6.1 <u>Purchases</u>. The Services may include the ability to make purchases through the Site. Any descriptions are provided for convenience purposes only. In the event a product or service provided on or through the Site is listed at an incorrect price or with incorrect information, we will have the right to refuse or cancel any reservations or orders placed for the program incorrectly listed, whether due to a typographical error or an error in information received from third parties. Certain products may be offered as part of a subscription that is subject to autorenewing terms and payment ("Subscriptions"). Subscriptions are subject to the auto-renewal terms set forth in Section 6.2 and 6.3 below.
- Payment and Payment Method. We use a third-party service provider to process payments ("Payment Processor") from you for any charges incurred by you when making a purchase using the Services. The processing of payments will be subject to the terms, conditions, and privacy policies of the Payment Processor in addition to these Terms. By choosing to make a purchase when using the Services, you agree to pay, through the authorized Payment Processor for payment processing services or as otherwise authorized by us, all charges at the prices then in effect, and where applicable, you authorize us, through the Payment Processor for payment processing services, to charge your chosen payment provider. YOU REPRESENT AND WARRANT THAT YOU HAVE THE LEGAL RIGHT TO USE ANY CREDIT CARD(S) OR OTHER PAYMENT METHOD(S) UTILIZED IN CONNECTION WITH ANY TRANSACTION MADE THROUGH THE SERVICES. In using the Services, you understand that payments may be returned for various reasons, such as, but not limited to, payment information that is provided is not valid or expired. You may receive notification regarding any such returned payments. You may be assessed fees by us or your financial institution as the result of any returns or insufficient funds related to your payment method, or charges refused by a card network or issuing bank.

6.3 Auto-Renewal Terms.

Upon enrollment in an auto-pay Subscription, you acknowledge that you agree that the Subscription is subject to auto-renewal terms and you understand that you will be automatically charged at the amount and frequency identified at the time of your enrollment until you cancel. 6.4 <u>Cancellation Policy</u>.

When You Must Cancel Your Subscription To Avoid Charges: You may cancel your Subscription any time up until 24 hours before the processing of the renewal fees for the Subscription. To identify your next renewal date, please go to your MyACSM Profile Account page by clicking on the MyACSM menu, navigate to My Profile and scroll down to "Membership Details" wherein you can see the start date of the next renewal charge listed.

WE DO NOT PROVIDE REFUNDS OR CREDITS FOR ANY PARTIAL-MONTH SUBSCRIPTION PERIODS. Requests to edit or cancel a Subscription made less than 24 hours prior to scheduled processing will be considered invalid, and the scheduled fees will be processed

How To Cancel Your Subscription: You may cancel your Subscription in a variety of ways:

- a. Click-to-Cancel Link: To cancel, visit our Site and go to your MyACSM Profile Account page by clicking on the MyACSM menu, navigate to My Wallet, remove the Subscription, and follow the instructions for cancellation. We may ask for limited information to verify your Account before you may cancel to the extent not prohibited by applicable law.
- b. **Email**: You may also cancel by emailing us at membership@acsm.org with "Cancellation" and the name of the auto-pay Subscription you wish to cancel in both the subject line and body of the email.

To the maximum extent not prohibited by applicable law, you agree to release, defend, indemnify, and hold ACSM and its affiliates, licensors, and service providers harmless from and against any claims, liabilities, damages, losses, costs, and expenses, or any other injuries, losses, or damages (whether compensatory, direct, incidental, consequential, or otherwise) of any kind, and including reasonable legal fees and litigation expenses and costs, arising out of or relating to or in any way connected with any User Content that you upload to the Site, your breach of the Terms, or your negligence or willful misconduct.

12. DISPUTE RESOLUTION AND GOVERNING LAW.

These Terms shall be governed by and interpreted in accordance with the laws of Indiana without regard to conflict of law principles. All disputes, claims, controversies, and matters relating to or in connection with the Terms or subject matter in connection therewith, shall be settled by binding arbitration administered by the American Arbitration Association under its Commercial Arbitration Rules ("<u>AAA Rules</u>"), and judgment on the award rendered by the arbitrator(s) may be entered in any court having jurisdiction thereof. The arbitration shall take place Indianapolis, Indiana before a single neutral arbitrator appointed in accordance with the AAA Rules and shall be conducted in the English language.

ALL ARBITRATIONS SHALL BE CONDUCTED AND RESOLVED ON AN INDIVIDUAL BASIS AND NOT A CLASS-WIDE, MULTIPLE PLAINTIFF, OR SIMILAR BASIS. NO ARBITRATION SHALL BE CONSOLIDATED WITH ANY OTHER ARBITRATION PROCEEDING INVOLVING ANY OTHER PERSON OR ENTITY.

13. MISCELLANEOUS

These Terms constitute the entire and exclusive understanding and agreement between you and ACSM regarding your access to and use of the Site and supersede and replace any and all prior or contemporaneous oral or written understandings or agreements between you and ACSM regarding the subject matter hereof.

You may not assign, transfer, delegate, subcontract, or sublicense any of your rights or obligations under the Terms. Any attempted assignment, transfer, delegation, subcontracting, or sublicense without the foregoing consent will be null and void.

No agency, partnership, joint venture, employee-employer, or franchisor-franchisee relationship is intended or created by the Terms. Any provisions of the Terms that contemplate performance or observance subsequent to the expiration or termination of the Terms shall survive such expiration or termination.

Our failure to exercise any right or enforce any obligation under the Terms or to take action with respect to a breach by you or others will not constitute a waiver of such right, obligation, or breach.

If an arbitrator or a court of competent jurisdiction finds any provision of the Terms to be invalid, void, or unenforceable, in whole or in part, for any reason, the offending provision will be enforced to the maximum extent permissible and will not affect the validity or enforceability of the remaining provisions, which will remain in full force and effect.

The headings in the Terms are for reference purposes only and do not limit or otherwise affect the meaning or interpretation of any of the provisions hereof.

Except as otherwise expressly set forth herein, the Terms do not and are not intended to confer any rights or remedies upon any person other than the parties hereto.
